**1. EVENT COORDINATOR:** The Event Coordinator for **Powerhouse of Deliverance** is Joseph Davenport. Therefore, Sands Resorts will coordinate directly with this Event Coordinator and accept changes only from Joseph Davenport.

**2. SUMMARY OF REQUIREMENTS:**

**a. Guest Room Requirements:** The following rates for your guest rooms will be offered for Wednesday, April 30, 2025 through Sunday, May 4, 2025 will be confirmed upon receipt of signed contract:

1) **The room rates do not include state and local taxes or applicable hospitality and resort charges currently 29.95%. Please note we do not control increases to taxes and they will be adjusted should taxes increase before the execution of your event. An access charge of \$3.58 per room per night will be applied to all guest folios and includes unlimited local and toll-free access telephone calls, and unlimited use of personal in-room safe.**

2) Maximum permitted occupancies for each unit are determined by Sands Resorts. Rates are based on the following:

	<b>Max # of pp allowed in room</b>
<b>Oceanview Double:</b> 2 Adults and 2 Kids	4
<b>1 Bedroom Villa:</b> 2 Adults and 4 Kids	6
<b>2 Bedroom Villa:</b> 4 Adults and 6 Kids	10
<b>3 Bedroom Condo:</b> 6 Adults and 6 Kids	12

3) Group room rates apply (3) three days before and after conference dates.

4) Group room rates do not apply to and cannot be used in conjunction with special promotional offers.

5) The minimum stay requirement over the dates of April 30, 2025 through May 4, 2025 is three (3) nights. It is necessary for all units within your room reservation dates to fall within this requirement.

6) We are expecting your group to meet the minimum number of ten (10) room reservations to qualify for the group rates provided. If your group does not meet the minimum requirements the current reservations pricing could be reverted to our standing rack rates, which could be at a higher rate.

### **METHOD OF RESERVATIONS: (INDIVIDUAL)**

We understand that reservations for your event are to be made by your attendees on an individual basis. Guests will be assisted by calling our Central Reservations at **1-800-599-9872** and ask for **Powerhouse of Deliverance**.

All reservations must be guaranteed by one night's deposit to be received within Seven (7) days of the reservation date, or a one night's deposit charged to a major credit card at the time of the reservation. Advance deposits will be credited to the last night's stay as indicated by individual reservation request.

All pre-registration forms that you might send out to your attendees must be approved by Sands Resorts.

**4. CHECK-IN PROCEDURES AND SPECIAL BILLING ARRANGEMENTS:** Our guest check-in time is 4:00 PM and check-out time is 11:00 AM. It is suggested that your members and guests plan to arrive after 4:00 PM. Please be assured, however, that every effort will be made to accommodate those guests who arrive at the Sand Dunes Resort and/or North Shore Resort, Myrtle Beach, SC prior to 4:00 PM. In the event of planned meetings that exceed 11:00 AM on your day of departure, attendees should be advised in advance of check-out time.

**5. ATTRITION POLICY:** No Attrition-Sleeping rooms are on a rate-hold only basis. We will offer the group rate up until (4/1/24) for your guests to call-in to make reservations. **Reservations received after this date will be honored on a space available basis and become subject to prevailing minimum night requirements and rack rates**

**The deadline for booking rooms at the group rate in April 15, 2025.**

may apply.

**6. CANCELLATION POLICY:** If you cancel reserved rooms, facilities or services, the hotel could suffer losses due to the expense and uncertainty of obtaining replacement business. To compensate the Hotel for such losses, there will be a mandatory processing fee of \$250.00. Additional fees will be charged and Powerhouse of Deliverance agrees to pay as follows:

Cancellation of individual room reservations up to seven days prior to arrival is subject to a \$50.00 processing per room. Cancellation of group room reservations within seven days prior to arrival date is subject to the loss of your deposit. All no shows will be billed for one night's accommodation.

**7. FORCE OF NATURE:** The performance of this agreement by either party is subject to Force of Nature, war, government regulation, disaster fire, strikes, civil disorder, curtailment of transportation facilities, or similar cause beyond the control of the parties making it illegal or impossible or inadvisable to hold the meeting/convention or provide the facility.

**8. EXHIBITS:** Sands Resorts understand that the **Powerhouse of Deliverance** will have no vendors or exhibits. Conference room space will not be sub-let without prior coordination and approval from the Director of Operations for Group Sales.

**9. SECURITY-LIABILITY-EVICTION:** The Hotel follows *The Lodging Establishment Act, Section 45-2-30*. If for any reason you are in violation of The Lodging Establishment Act, we have the authority to evict you and/or your attendees from the property. This means cancelling any banquet functions scheduled. The Hotel also reserves the right to inspect and control all private functions to assure that they are being conducted in a manner consistent with Hotel safety standards and ensure the comfort of other Hotel guests. To guarantee the terms of this contractual agreement, please sign and return the contract as soon as possible and not later than **December 5, 2024. Upon receipt of the signed contract, our office will block all space requirements and/or guest rooms on a definite basis. Please allow at least (3) days after receipt of the countersigned contract.**
